- Licence Types are defined in a Section 23 Notice published from time to time in the Gazette by the ICT Authority, a copy of which is available on the Authority's web site at [www.icta.ky](http://www.icta.ky).
- You should use this form (ICTA Form P) if you wish to apply for or renew one or more Land Mobile Radio Licence(s).
- This form must be accompanied by:
  - The appropriate fee (currently CI\$20 per radio)
  - Schedule to Form P, listing the individual makes, models and serial numbers of radios to be licensed.
